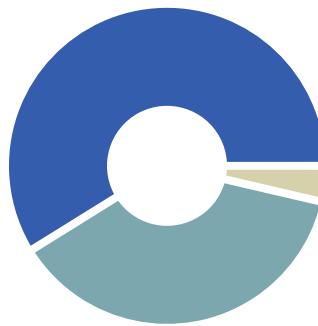

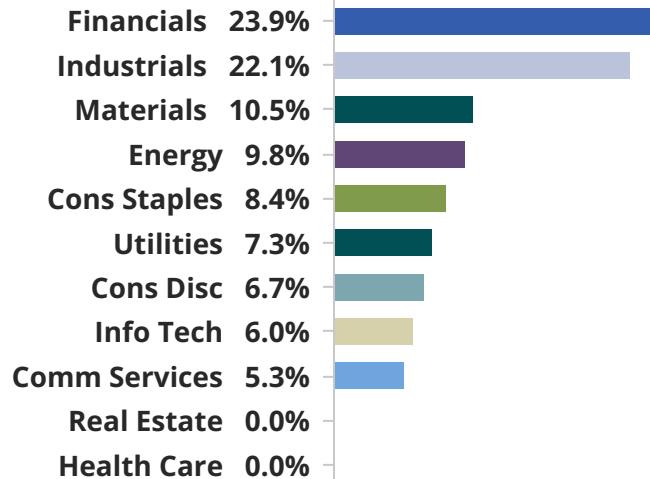
## QV Canadian Balanced Fund Composition
