Objective - consistent growth with below-average risk

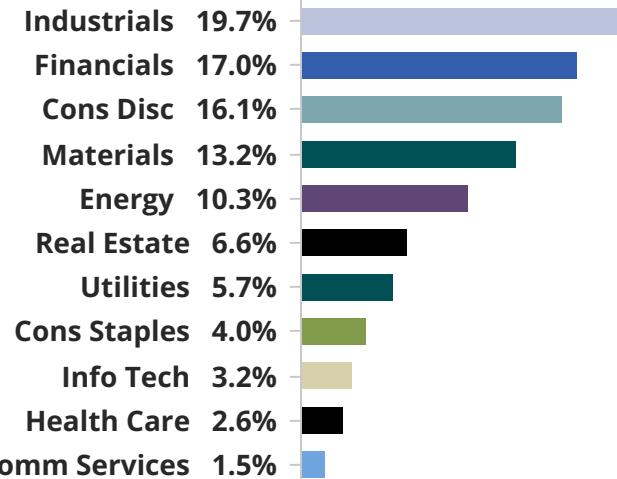
QV Canadian Small Cap Fund Composition

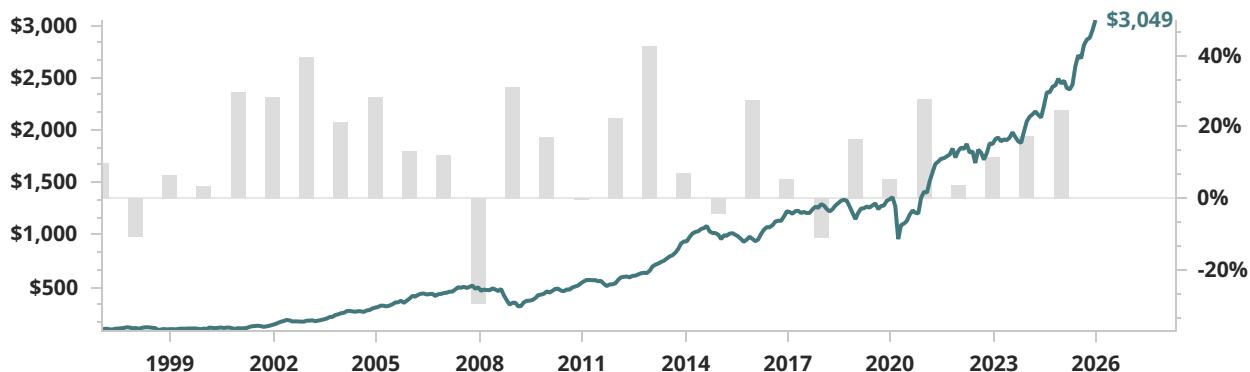
